Colony Post, Coimbatore- 641022, Tamil Nadu against grant of accreditation status "Not Accredited" to the Master of Business Administration program of your Institution, communicated vide NBA's letter of even number dated 08/11/2023.

2. The appeal was considered by the Appellate Committee of NBA in its meeting held on 23/04/2024. The Appellate Committee recommended re-evaluation of Master of Business Administration program by conducting re-visit to Sri Ramakrishna Engineering College, Vattamalaipalayam, N.G.G.O. Colony Post, Coimbatore- 641022, Tamil Nadu. An Expert Team conducted onsite evaluation of the program from 19th to 21st July, 2024. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. 


